ACTION ITEM -- MARCH 12, 2024 POLICY/OPEN DISCUSSION WORKSHOP SUMMARY

1. Superintendent's Recommendation:

That the School Board of Seminole County accept as part of its permanent record this report of the March 12, 2024 Policy/Open Discussion Workshop.

2. Background/Analysis:

Chair Abby Sanchez called to order the March 12, 2024, Policy/Open Discussion Workshop at 2:05 p.m. Board members present were Chair Abby Sanchez, Vice-Chair Kristine Kraus, Member Kelley Davis, Member Autumn Garick, and Member Amy Pennock. Also present were Superintendent Serita Beamon, School Board Attorney Karlene Cole-Palmer, Deputy Superintendent Dr. Anna-Marie Cote, Assistant Superintendent of Operations Dr. Mark Mullins, Assistant Superintendent of Student Support Services Amy Elwood, School Psychologist Rona Richardson, and Teachers on Assignment-Curriculum Support Jennifer Smith and Deborah Bidwell.
